- Constitution is the highest form of law (need to get it as close to right or have the option to change with a reasonable threshold, otherwise get ready to be inconsistent with the constitution)
- Those that are elected to represent you through a democratic process are the law making authority! (That's it, you no longer look to anyone to see if you are doing it the right way, because whatever you chose is the right way)

So what's different

- Under the Indian Act: Chief and council have limited scope of powers that only apply to Indian Reserves, and they have to seek approvals from the Federal Government.
- As chief and council you are responsible to ensure programs and services are delivered as directed by the Federal Government, and work within the frameworks provided

Lessons learned

- Change management is critical
- Moving from mindsets of entitlement to empowerment
- Have to move the thinking to long term from 1-2 years to 20 years and beyond
- You design your future and your destiny
- You manage and direct your budget
- You build your nation on your terms

What can you do to prepare

- Good Governance is critical and should be invested in early.
- Establishing your team, the work now is done at the administration level so having the right team in place is essential.
- Have a good vision, community engagement is essential, engage early and often. Keep people informed!
